BOOT CAMP involves hands-on selection & due diligence process of companies seeking \$30-50k. Your BOOT CAMP experience gives you overview and introductions to our on-the-ground teams for later investments up to \$500k.

BOOT CAMP is 100% in English and provided in conjunction with our Impact Investment partners.

COSTS

There are 2 ways to join:
as a full investor participant;
or as sponsored business lead.

In either case, we arrange all local costs: meals, accommodation & local transport; you arrange your own flight(s) to Kenya.

CBA is self-funded; all contributions are invested in local impact opportunities as selected by BOOT CAMP participants.

MISSION of CBA / About CBA

The Christian Business Angels (CBA) helps local entrepreneurs grow businesses in their country by providing financing plus business coaching. By doing so, we seek to create meaningful and sustainable employment, while growing businesses that honor God and set the example for others to follow.

PURPOSE of Trip

The purpose of the BOOT CAMP is both to give Impact Investors a hands-on experience of the Impact Investment process, and also to complete 1-2 smaller (\$30-50k) Impact Investments, as selected by BOOT CAMP participants.

Fee Details

Per-person contribution is \$5000; spouse or partner in same room additional \$2000. Contribution can be donation from self or own business; or funds can be raised through our sponsor program.

BOOT CAMP Dates & Agenda

There are 2 trip dates planned for 2026 to provide flexibility. Both trips have a similar agenda to accomplish our purpose; you should plan to attend on the date that fits best for you.

Both trips follow the planned agenda listed below:

Saturday	arrival in Nairobi
Sunday	local church service, team get-together, introductions & trip review
Monday	visit existing Impact Investments to gain perspective
Tuesday	Business Growth workshop / meet new entrepreneur candidates
Wednesday	site visits to best candidates for new Impact Investment
Thursday	funding pitches from local entrepreneurs
Friday	selection of new investment candidate(s); initial due diligence visit evening or next-day return flight

BOOT CAMP is a hands-on experience to take participants through all aspects of Impact Investing on location in Kenya. Participants will be ready to make Impact Investments through CBA or their agency of choice, from \$10-500k. Fees paid for program participation are 100% invested at the direction of BOOT CAMP participants.

In both cases, participants arrange their own flight to Nairobi, but local hotel, meals & transportation are paid by CBA.
